SUMMARY

Offer Price

- The Offer Price has been determined at HK\$1.0 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$1.0 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commission and other estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately HK\$96.3 million. The Company intends to apply such net proceeds in the manner set out in the paragraph “Net Proceeds from the Share Offer” in this announcement.

Applications and Indications of Interest Received under the Public Offer

- The Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 12,050 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** service for a total of 137,090,000 Offer Shares, representing approximately 9.87 times of the total number of 13,885,000 Public Offer Shares initially available for subscription under the Public Offer.
- The over-subscription in the Public Offer is less than 15 times. At the discretion of the Joint Bookrunners and Joint Lead Managers, no reallocation procedure as disclosed in the paragraph headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus has been applied and no Placing Shares have been reallocated from the Placing to the Public Offer. The final number of Offer Shares under the Placing is 124,965,000 Offer Shares (including the Employee Reserved Shares and the Offer Shares subscribed by the Cornerstone Investors), representing approximately 90% of the total number of Offer Shares under the Share Offer (without taking into account any Shares which may be issued pursuant to the exercise of any options which may be granted under the Share Option Scheme). A total number of 171 placees (including 83 successful Eligible Employees and six Cornerstone Investors) have been allocated Offer Shares under the Placing.

83 valid applications have been received for a total of 10,330,000 Employees Reserved Shares pursuant to the Employee Preferential Offering on the **PINK** Application Forms, representing approximately 74.58% of the 13,850,000 Employees Reserved Shares initially available for subscription under the Employee Preferential Offering. All of the 10,330,000 Employees Reserved Shares validly applied for will be allocated to Eligible Employees who have applied pursuant to the Employee Preferential Offering. As the Employee Preferential Offering has been under-subscribed, a total of 3,520,000 unsubscribed Employee Reserved Shares have been made available for subscription by the placees under the Placing.
